DEALER RELEASE OF LIABILITY

The Dealer hereby indemnifies and holds harmless the Producer, its agents, employees and servants and the Beneficiary, its agents, employees, and servants from any and all claims, including costs and attorneys fees resulting there from, arising out of said Dealer's participation in this event. For the purpose of this agreement, the term "participation" shall include, but not be limited to, the delivery of equipment, merchandise, structures and product to their designated location, the set up and display of any such product or service, and the dismantling and removal of all such items from the area provided by or through the Producer or its agents, employees and servants.

The Dealer hereby expressly assumes the risk of harm to the Dealer arising out of their participation and the participation of its agents, employees, and servants in the Marin Sonoma Concours d' Elegance, including any risk resulting from the particular location of the space designated to them by the Producer.

In addition, all Dealer shall name the Marin Sonoma Concours d' Elegance as additional insured on their liability insurance for the day of the event.

This agreement shall be effective immediately upon execution, and shall continue in effect throughout the event.
